Key Responsibilities

- Performing timely monitoring and controlling the cash flow of WorldFish such as monitoring investments, receipts and disbursements and preparation of cash position report and cash flow projections;
- Establishing safe bank based on the investment guidelines and bank accreditation procedures in conducting annual evaluation of banking service providers;
- Managing WorldFish's opening and closing of bank accounts;
- Performing timely resolution of long outstanding bank reconciling items for all bank accounts in WorldFish;
- Providing advice on impact of foreign exchange exposure in project and making recommendations on the opening of foreign currency bank accounts other than the existing currencies;
- Maintaining and controlling treasury database;
- Implementing and supervising electronic banking;
- Documenting criteria and comparisons made between or among investment opportunities before investment decisions are made;
- Managing exchange rate for project budget to maximize returns on foreign exchange holding;
- Administering and monitoring investment portfolio to ensure optimization of returns and rates on idle cash, for example, but not limited to -
 - Recommending the best financial instruments for investments e.g. time deposits, REPOs, overnight money market;
 - Leveraging on banks' treasury expertise and recommendations.
- Monitoring and ensuring timely renewal of BG;
- Monitoring and ensuring that the guidelines for the management of Employee Provident Fund for the Philippine office are adhered to;
- Coordinating and liaising with internal auditors in the compliance with CG guidelines on internal controls, Center policies, processes and risk management practices built; and
- Responsible for proper maintenance of files and their archiving.
