# **CBRM** Approach



**Importance of Coastal Resources:** Food & Nutrition, Livelihood, Shelter-Island building, cultural traditions, transport, economic development.

•Resource Owners

- •Primary rights
- •Customary marine tenure 90% of inshore coastal areas
- •Coastal population reside and depend on coastal and marine resources

•Dependency on resources: food & nutrition, economic benefits & livelihood, cultural values and traditions.

**NPOA** = CBRM founding policy for putting CBRM as focus for MECDM and MFMR




•Aim to ensure CBRM services reaches all 4000 coastal communities or at least 50% of them by 2020.
